## Alberta Education Ministry Bullies Families

Alberta has recently released its new mandatory guidelines<sup>1</sup> on sexual diversity in schools.

NDP Education Minister David Eggen said the new guidelines ensure the “safety” of transgendered students.

Of course, you would have to seek long and hard, and stand truth on its head, to find where transgendered students have been less ‘safe’ than any other students.

So, we will have to assume that the word ‘safe’ does not refer to physical safety but rather to having their thoughts affirmed as correct and indisputable... except by the ‘bad people, who offend my feelings’. And, of course, those ‘bad people’ have no right to their own thoughts or opinions.
